AIRPORT LANDING FEE PROGRAM

As of March 1 2025, The Pennridge Airport will enact an Aircraft Landing / Parking Fee Program for all aircraft greater than or equal to 1,000lbs MLW. The revenue generated will supplement costs incurred for airport maintenance and operation per FAA Grant Assurances. The program is intended to impose fair and reasonable charges in association with usage of airport facilities. Touch n Go's are considered landings per the FAA.

Exemptions from landing fees will be as follows: aircraft engaged in non-profit patient airlift services and non-profit firefighting services, Pennridge Airport based aircraft defined as an aircraft that has an agreement in good standing with Pennridge Airport or its FBOs for parking or hangar space; or any aircraft that is based at the airport for the majority (183+) of the days per calendar year.

EXEMPT AIRCRAFT

-Aircraft engaged in non-profit airlift services and nonprofit firefighting services -Pennridge Airport based aircraft, defined as an aircraft that has an agreement in good standing with Pennridge Airport or it's FBOs for parking or hangar space or any aircraft that is based at the airport for the majority (183+) of the days per calendar year.

OPERATIONAL CONTROL AND MONITORING

At the Airport Manager's discretion, the airport may contract with a third-party vendor to manage and/or collect these fees.

PROGRAM REVIEW

The rates will be reviewed annually, and any adjustments shall be made prior to the start of the next year after the manager's approval. The review will consist of reviewing the fees of the airports in the region and determining a rate for Pennridge Airport that is consistent with the financial viability of the airport.
